

**RUGBY CITY COUNCIL
RE-ORGANIZATION MEETING
TUESDAY, JUNE 23, 2020 - 7:30 P.M.
COUNCIL CHAMBERS OR GOTOMEETING**

Council Members present: Albrecht, Lunde, Kraft, Bednarz, Berg, LaRocque and Trottier. Also present: Mayor Steinke and City Auditor Stewart. Absent were Council Member Longie and City Attorney Hartl.

Mayor Steinke called the meeting to order. Council members recited the pledge of allegiance to the flag. Roll call of council members by Mayor Steinke.

The council reviewed the Pierce County canvassing board official abstract of votes from the joint city/county election held on June 9, 2020. The results were as follows:

Ward 1 Council Member - 4 year term –Matthew Lunde– 3 votes.

Ward 2 Council Member - 4 year term – Gary Kraft – 90 votes.

Ward 3 Council Member - 4 year term – Frank LaRocque- 163 votes

Ward 4 Council Member - 4 year term – Wayne Trottier – 4 votes.

Park Board Commissioners - 4 year terms - 2 positions – Sara Radomski - 451 votes cast and Tim Bartsch Jr. – 543 votes cast.

City Measure No. 1 – Publication of Minutes - Yes – 654 votes cast, No – 29 votes cast.

Motion by Kraft to accept the abstract of votes as certified by the Pierce County Auditor and the Pierce County Canvassing Board. Second by Albrecht, all voting yes, motion carried.

Mayor Steinke administered the official Oath of Office and swore in the following elected officials: Matthew Lunde as Ward 1 Council Member, Gary Kraft as Ward 2 Council Member, Frank LaRocque as Ward 3 Council Member and Wayne Trottier as Ward 4 Council Member.

Mayor Steinke presented Bruce Rheault with a plaque commemorating his years of service to the City of Rugby.

Mayor Steinke called for nominations for Council President. Motion by Albrecht to nominate Kraft for Council President. Second by Bednarz, all voting yes, motion carried.

Mayor Steinke called for nominations for Council Vice President. Motion by Berg to nominate LaRocque for Council Vice President. Second by Albrecht, all voting yes, motion carried.

Mayor Steinke made the following Committee assignments: **Finance:** Gary Kraft, Jacqueline Albrecht, and Wayne Trottier. **Public Works:** David Bednarz, Gary Kraft, and Chuck Longie. **Public Safety:** Chuck Longie, Frank LaRocque, and Wayne Trottier. **Ordinance:** Gary Kraft, Jacqueline Albrecht, and Matthew Lunde **Recreation:** Joel Berg, David Bednarz, and Frank LaRocque. **Personnel:** Jacqueline Albrecht, Chuck Longie, Frank LaRocque, and Candy Munyer.

Building/Property: Joel Berg, Dave Bednarz, Matthew Lunde. **Tree:** Gary Lee (City Forester), Yolanda Schmidt, Tim Bartsch Jr., Troy Munyer, and Jacqueline Albrecht.

Mayor Steinke made the following new appointments: **Building Official/Inspector:** Wayne Schmaltz. **LEC - City Representatives:** Wayne Trottier. **City Planning/ Zoning:** Wayne Trottier. **CVB:** Jacqueline Albrecht.

There was a motion by LaRocque to approve the Committee Appointments and other Appointments made by the Mayor. Second by Albrecht, all voting yes, motion carried.

Mayor Steinke administered the official Oath of Office and swore in the following: Park Board Member: Tim Bartsch Jr. Building Inspector: Wayne Schmaltz.

The council reviewed the reminders.

There being no further business to transact or to come before the Council at this time, motion by Albrecht to adjourn the meeting at 7:40pm. Second by Bednarz, all voting yes, motion carried.
